





# 1. Description

The RWX78M / RWX78MBL / RWX78MBR is a 2-way supervised transmitter that combines Magnetic/Door Contact (against opening doors and windows).

The RWX78S / RWX78SBL is a 2-way supervised shock detector that employs an accelerometer for shock detection.

The RWX78SM / RWX78SMBL / RWX78SMBR combines both a Shock detector and a Magnetic Contact detector in a single casing for internal use that provides reliable 24-hour perimeter protection


The RWX78M / RWX78MBL / RWX78MBR / RWX78S / RWX78SBL / RWX78SM / RWX78SMBL / RWX78SMBR operates with LightSYS Plus / LightSYS Air Systems.



## 2. Installation

## Step 1: Selecting the Mounting Location

Select a location best suited for communication quality. RISCO recommends you place the unit at the highest possible position.

## Step 2: Mounting the Detector

- 1. Open the detector plastic cover from the bracket (see Figure 1).
- Secure the detector bracket using the two supplied screws bracket (see Figure 2).

#### Notes:

- Alternatively, you can use the double-sided adhesive (if supplied with your model) that does not require opening the detector.
  The white side of the adhesive should be used for mounting the detector on a hard surface, such as, wood. The gray side of the adhesive should be used when mounting the detector on a softer surface.
- 2. The magnet must be mounted alongside the mark on the detector's plastic case (Figure 2).

*Note:* The double-sided adhesive is not approved for use in EN50131 installations.

## Step 3: Registering the Detector into the System

The detector must identify itself to the system receiver in a device allocation (enrollment) process, which is performed either by entering the detector's 11-digit serial number or by the following RF sequence registering:

- 1. Set the receiver to Learn mode.
- 2. Remove the battery divider (see Figure 4).
- 3. Reattach the detector to the bracket (see Figure 5a).
- 4. Wait at least 3 seconds to send a WRITE message.

Successful learning will be indicated by a confirmation message that indicates the detector alloction in the system.

#### Notes:

- a. In case of performing device allocation (enrollment) by entering the detector's 11-digit serial number, make sure to use the serial number of the Main Unit (by scanning the QR sticker on the package via the HandyApp application).
- b. In case of Magnetic Contact and Shock Detector (RWX78SM), it is required to perform registration only once (the panel will automatically add an additional zone).

## Step 4: Mounting the Magnet

- 1. Secure the bracket using the two supplied screws (see Figure 3). *Note: Alternatively, you can use the double-sided adhesive.*
- 2. Attach the cover to the magnet bracket (see Figure 5b).

# 3. Battery Replacement

- 1. Open the detector plastic cover from the bracket (See Figure 1).
- 2. Use a screwdriver to remove the old battery.
- 3. Insert a new battery (See Figure 6).

Observing battery polarity, insert a CR2450 battery (supplied) into the battery compartment.

Risk of explosion if battery is replaced by an incorrect type. Dispose of used batteries according to local regulation.

4. Reattach the detector to bracket (see Figure 5a).

# 4. Detector Configuration

Being bi-directional, the detectors parameters can be modified from the keypad or from the system configuration software according to your needs.

Hold is used to determine the detector **HOLD** status.

**ON:** There will be 2.5 minutes dead time between the alarm detection transmissions. (Restore messages will be sent immediately.)

Note: Only one alarm message is transmitted in any 2.5 minute period.

**OFF:** No dead time between alarm detection transmissions (the unit transmits after each detection).

# 5. LED Indication

After each detection, the LED turns ON momentarily. On Low Battery condition – the LED will blink during each transmission.


